

FLEX-TELLER IS A SAFE & "GREEN" SOLUTION

As of March 31, 2008 Glenview Credit Union will be converting from printed, mailed statements of your account activity to E-Statements. An increasing number of our members use FlexTeller to manage their accounts online. They have told us they enjoyed banking in a convenient, secure and "green" way! Now E-Statements further enhances the benefits of FlexTeller.

E-Statement Advantages

- **Convenient** – E-Statements are stored online, and you access a significant history of your past statements.
- **Secure** – Only you can access your E-Statements using your secure account log in. Paper documents can be diverted or stolen from your mail.
- **Fast** – E-statements are available online days before paper statements arrive by mail.
- **Eco-Friendly** – E-Statements save paper and fuel delivery costs.
- **Cost-Efficient** – E-Statements save the credit union money; passing the savings along to our members.

What is an E-Statement?

It's an electronic 'copy' of your account statement that you can view, search, and save online. You can also print it out from your own computer, should you need to.

How do E-Statements work?

You will be notified by email that your statement is available for retrieval. You'll then log on to FlexTeller, your online account access site at www.glenviewcu.org to view or print your statement. REMEMBER, we will never send you a link — you will always be in control of account access yourself. This is just one of the many safety features our financial software programs have.

Please take a moment to make sure you are signed up for the FlexTeller program. If you do not yet have FlexTeller, please use the form on the next page to register before March. It is important to make sure that GCU has current contact information on file. Verify and update your email address with us.

What if I still want paper statements?

Just complete the request form on the back of this newsletter, make sure we have your current mailing address, and return it to us before March 31, 2008 to ensure uninterrupted delivery. ❖

IRAs with an account balance below \$7,500 are charged an annual \$28 administration fee. This fee helps to offset the cost of maintaining IRA records, IRS reporting, providing tax information statements, etc. Avoid this administration fee by increasing your IRA balance before June 30, 2008. ❖

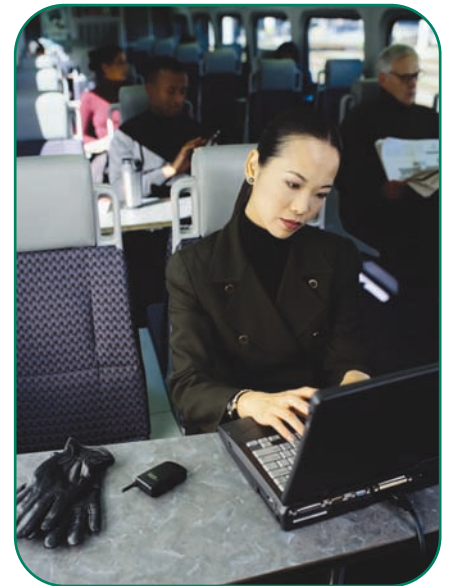
